- 1. The front loading of payments last season with £100 initial payment, then £75 for mother club, £65 all others continues to be successful in bringing a better balance to the accounts and meeting all the bills without fear of the club running out of money.



# 11. Any Other Competent Business (A.O.C.B.)

Website.

The club website continues to be well used, but by members?



Note: Analytics switched on at the end of September 2019.

25% of all users are return visitors.

23% of browsers have Stirling as their location.

They stay on the website for more than 2 minutes and look at 3 pages on average.

63% of users come directly to the site.

Half of all users enter the site by the home page.

External Games pages are most looked at outwith the home page.

Current website <a href="http://sauchieandbannockburncurlingclub.moonfruit.com/">http://sauchieandbannockburncurlingclub.moonfruit.com/</a> is an Adobe Flash site, this technology is being decommissioned by December 2020, thus the need to move to a new one. The subscription is £26.99 pa and expires January 2021.

3 options have been evaluated and a different service provider is being recommended for next season.

Weebly is a US Provider. It can be free but there is a limit on what can be done, it would cover most of the club's requirements. However, the Weebly footer is a major annoyance as it is meant to encourage users to move to a plan. There would be two plans of interest.

(Note: Connect - Connect to a custom domain £48 billed annually.

Pro - Build a professional, branded website for your business £108 billed annually. Both unlock greater levels of functionality.)

Connect is the least expensive option, an increase of £21 over the current Moonfruit site. As it is a relatively small increase the Connect option is favoured.
